State Budget – HB 49

□ Process/Timeline

- Gov. Introduced – Early Feb.
- Press Conference on Revenues – April 13
- House Version Finalized – May 2
- Senate Version Finalized – June 21

State Budget – HB 49

□ Process/Timeline

- Conference Committee – June 27
- Final Bill Passed – June 28
- Gov.'s Signature/Vetoes 47 Items – June 30
- House Overrides 11 Vetoes – July 6
- Senate Overrides ???

State Budget – HB 49

□ Public Library Fund (PLF)

- Permanent Law – 1.66% of GRF
- Temporary Law – 1.68% for FY18 & FY19

□ Legislative Service Commission (LSC) Estimates

FY 2017	FY 2018	FY 2019
\$378.6 Million	\$380.8 Million	\$393.5 Million

State Budget – HB 49

- **Ohio Workforce Transformation (OWT) Provisions**
 - **Leveraging Ohio’s Public Libraries in Adult Education**
 - **OhioMeansJobs Center MOUs w/ Public Libraries**
 - **Brand Libraries as “Continuous Learning Centers”**
 - **Strengthen the Ohio Digital Library**

State Budget – HB 49

- **Local Government Provisions**
 - **Increase in County Treasurer Tax Collection Fees**
 - **Investment of Inactive Funds by Counties**
 - **Property Tax Resolution Language**
 - **Changes to CAUV Calculations**

State Budget – HB 49

□ Tax Provisions

- Reduces the Number of Tax Brackets
- Sales Tax Holiday in 2018

State Budget – HB 49

□ Other Provisions

- **Storage of Firearm in Privately Owned Vehicle**
 - Creates a civil cause of action against employer with policy that prohibits CCW holders
 - Limits court to injunctive relief

State Budget – HB 49

- **What is NOT in the Final Bill?**
 - Major Tax Cuts
 - DataOhio
